হাসপাতালের আইসিইউ'তে গণধর্ষণের অভিযোগ যোগী রাজ্যে

লখনউ, ৪ অক্টোবর : উত্তর প্রদেশের বরেন্দিতে হাসপাতালের আইসিইউ'র মধ্যে গণধর্ষণের শিকার এক নাবালিকা। এই ঘটনায় হাসপাতালের কর্মীসহ ৩ জনের বিরুদ্ধে থানায় অভিযোগ দায়ের করেছে নাবালিকার পরিবার। তদন্তে নামেছে পুলিশ।

পুলিশে অভিযোগ জানিয়ে নাবালিকার বাবা জানিয়েছেন, বিবাস্ত পোকার কামড় খেয়ে মঙ্গলবার রাতে হাসপাতালে তাঁর মেয়েকে ভর্তি করেন তিনি। তাঁকে সঙ্গে সঙ্গে আইসিইউতে ভর্তি নেওয়া হয়। সেখানেই বুধবার রাতে তাঁর মেয়ে ধর্ষণের শিকার হন। বরেন্দির পুলিশ সুপার অভিনন্দন সিং জানিয়েছেন, ধর্ষণের সময়ে চিৎকার করার মতো পরিস্থিতি ছিল না নাবালিকার। শুক্রবার যখন তাঁকে জেনারেল ওয়ার্ডে নিয়ে আসা হয়, তখনই সব কথা পরিবারের সোঁককে জানান ওই নাবালিকা। আইসিইউ'র বেডে-ই ধর্ষণ করা হয় তাকে। বিছনার চারপাশ বড় পর্দা দিয়ে ঘেঁরা ছিল। ফলে বিষয়টি

বিরুদ্ধে ধর্ষণের অভিযোগে এফআইআর দায়ের করা হয়েছে। অভিযুক্তদের বিরুদ্ধে পকসো আইনেও মামলা দায়ের করা হয়। অভিযুক্তদের ধরতে পুলিশের ২টি দল গড়া হয়েছে।

গত শনিবার নাবালিকার মেডিক্যাল পরীক্ষা হয়। সেইসঙ্গে ওই নাবালিকা যে পোশাক পড়ে আইসিইউতে শুয়ে ছিল, সেই পোশাক ফরেনসিক পরীক্ষার জন্য



পাঠানো হয়েছে। পুলিশের এক অধিকারিক জানিয়েছেন, তদন্তকারীরা হাসপাতালের রোগী ও কর্মীদের সঙ্গে কথা বলেছেন। সেদিন আসলে কী হয়েছে, তা জানার চেষ্টা করছেন তদন্তকারীরা। যদিও যাবতীয় অভিযোগ নস্যাৎ করে দিয়েছে হাসপাতাল কর্তৃপক্ষ। হাসপাতালে কর্মরত এক অধিকারিক জানিয়েছেন, গত বুধবার আইসিইউ'র মধ্যে অন্যান্য রোগীরা ভেে ছিলই, এছাড়াও হাসপাতালের ৩ জন কর্মী ছিলেন। কিন্তু কেউই ওই নাবালিকার অভিযোগের ব্যাপারে কিছু বলেননি। তবে
